

**Chap. 4.** AN ACT AUTHORIZING THE DENNIS WATER DISTRICT TO BORROW MONEY OUTSIDE ITS DEBT LIMIT FOR THE PURPOSE OF IMPROVING ITS WATER SYSTEM.

*Be it enacted, etc., as follows:*

SECTION 1. The Dennis Water District may, within a period of five years after the effective date of this act, borrow from time to time such sums as may be necessary, not exceeding, in the aggregate, one million, four hundred thousand dollars, for the purpose of constructing a new standpipe, laying and relaying water mains of not less than sixteen inches in diameter, constructing buildings for pumping stations, and for original pumping station equipment and wells. Said District may issue bonds or notes therefor which shall bear on their face the words, Dennis Water District Improvement Loan, Act of 1966. Each authorized issue shall constitute a separate loan, and such loans shall be payable in not more than twenty years from their dates. Indebtedness incurred under this act shall be in excess of the limit provided for by section eight of chapter forty-four of the General Laws, but shall, except as provided herein, be subject to the provisions of said chapter forty-four.

SECTION 2. This act shall take effect upon its acceptance by a majority of the voters of the Dennis Water District present and voting thereon at an annual or special district meeting.

**Chap. 5.** AN ACT DIRECTING THE BUILDING INSPECTOR OF THE TOWN OF DEDHAM TO ISSUE A PERMIT TO THE DEDHAM HOUSING AUTHORITY TO CONSTRUCT A MULTIPLE TWENTY-FOUR UNIT LOW-INCOME HOUSING PROJECT.

*Be it enacted, etc., as follows:*

SECTION 1. Notwithstanding the provisions of chapter forty A and chapter one hundred and forty-five of the General Laws, the building inspector of the town of Dedham shall issue a permit to the Dedham Housing Authority, if said authority acquires title to the parcel of land hereinafter described, to construct a multiple twenty-four unit low-income housing project on a parcel of land on High and Bussey streets in said town as shown on a plan entitled "Dedham Housing Authority Bussey Street Project Mass. R-78 Preliminary Subdivision Plat #7 Parcel #3", dated November 1964, containing sixty thousand eight hundred square feet, more or less.

SECTION 2. This act shall take effect upon its acceptance by the town of Dedham in the current year. *Approved February 23, 1966.*

**Chap. 6.** AN ACT DIRECTING THE BUILDING INSPECTOR OF THE TOWN OF DEDHAM TO ISSUE A PERMIT TO THE DEDHAM HOUSING AUTHORITY TO CONSTRUCT A MULTIPLE EIGHTY UNIT HOUSING PROJECT FOR THE ELDERLY.
